On January 11, 2024, the Court signed an order to show cause giving VDARE over one month to serve opposition papers, which were due pursuant to the Court's order by February 13, 2024. The order to show cause further provided that Petitioner was to serve reply papers on February 20, 2024, and the parties were directed to appear for oral argument on February 27, 2024.

On Sunday afternoon, February 25, 2024, alternate counsel, Jay Wolman, who has been representing VDARE in collateral federal proceedings, entered a notice of appearance in this case and filed untimely opposition. Petitioner asserts that VDARE's opposition papers raise new issues and arguments to which Petitioner has not had an opportunity to respond. By letter dated February 26, 2024, Petitioner requested that the Court strike VDARE's belated opposition papers or alternatively grant Petitioner additional time to respond.

Additionally, the court notes that Motion Seq No 6 has since been filed and adjourned by the parties to March 14, 2024. That motion raises issues related to this motion, and the court would prefer to address them together.


WHEREFORE it is hereby:

ORDERED that Petitioner shall file reply papers on or before March 14, 2024; and it is further

ORDERED that both parties may file proposed orders on or before said date; and it is further

ORDERED that such proposed orders include language addressing protection for the production of confidential information as well as language addressing the issues raised in Motion Seq No. 6; and it is further

ORDERED that Motion Sequence No. 4 will be marked submitted without further argument on March 14, 2024.
